The Honourable W. Thomas Malloy, O.C., S.O.M., Q.C.



I was invited to attend the official portrait unveiling of His Honour W. Thomas Molloy at the Saskatchewan Legislature on 23 November 2023

Legislative & Parliamentary members, along with the Chief Justice and other dignitaries (including the current LG & Premier) where in attendance.

It was an honour serving him as an Aide-de-Campe and as a side note, I was part of his state funeral as a member of the Honour Guard (hens the invite to the unveiling).

His portrait is now on display with all of the other LG's in the Legislative building.

William Thomas (Tom) Molloy was sworn-in as Saskatchewan's 22nd Lieutenant Governor on March 21, 2018.

He was born and raised in Saskatoon and completed his Law Degree at the University of Saskatchewan. He was called to the Bar in Saskatchewan in 1965, and worked in general practice until he found his calling as a skilled negotiator.

Tom was often referred to as a "modern father of Confederation) for his work in treaty-making and reconciliation with Indigenous Peoples of Canada.

He was an inspired choice as Chief Federal Negotiator for Canada, which led him to the negotiation tables for the Agreement that led to the creation of Nunavut in 1999, the Nisga'a Treaty, the Inuit of Northern Quebec Off-Shore, and the Lheidle T'enneh and Sliammon Final Agreements. Through those consultations, long-term friendships were made, and common understanding and respect were created. His work changed the face of Canada.

In addition to a distinguished legal career, Tom served as Chancellor of the University of Saskatchewan from 2001 to 2007, and later became Chancellor Emeritus. His award-winning book The World is our Witness: The Historic Journey of The Nisga'a into Canada was published in 2000.

In acknowledgement of his impressive professional achievements and outstanding community service, Tom was awarded an Officer of the Order of Canada in 1996, he was invested with the Saskatchewan Order of Merit in 2012, was awarded an Honorary Doctor of Laws Degree from the University of Saskatchewan in 2009 and received the prestigious 2018 Ramon John Hnatyshyn Award for Law from the Canadian Bar Association, among many other honours and awards.

He participated in hundreds of events, earning the admiration and affection of people across the province. He took part in many celebrations with Indigenous communities, in addition to his support for youth, mental health initiatives, literacy, new Canadians, and seniors.

William Thomas Molloy passed away on July 2, 2019, at the age of 78 after a short battle with pancreatic cancer.

Election results - Board of Directors, Royal Canadian Air Force Association

As a result of the general election (on-line) held from 15 November to 15 December 2023, the following members-in-good-standing of the RCAF Association were duly elected by their fellow Association members to the Board of Directors of the RCAF Association. There were eleven candidates vying for nine positions. I regret the delay in sending this out, I wanted to be sure the numbers were correct, and our ED has re-verified their accuracy. With this system, our members have once again indicated that they were pleased to be able to select their Board, rather than then old system where Group presidents automatically assumed these key positions in the Association. I am doubly pleased that we have finally been able to get a MAL member formally on our Board. Progress indeed!!

The following nine individuals were elected to the Board by majority vote - (In alphabetical order)

As duly elected directors, with the mandate to represent the RCAF Association to all the members everywhere, they will be sworn in during a ceremony being planned for **2 April 2024**. As is our custom, the current Board will conduct routine business as usual until that date. My sincere congratulations and thanks go to all who took the time and effort to stand for these positions.

Shortly thereafter, if not immediately following the swearing-in-ceremony, these nine elected directors will meet and consider two substantive motions without delay:

- The election from amongst themselves of someone to serve as chairperson of the RCAF Association Board
 of Directors. I have indicated my desire to step away from this position after a considerable period in the
 chair. Accordingly, all those members who believe they can fill this position should contact me soon to
 discover what is involved in this job, and then let it be known to their fellow board members that they
 would assume the position if elected to it.
- 2. The Board must also consider the appointment of up to three additional voting or non-voting directors in the capacity as Appointed Directors. The following individuals are eligible for appointment and merit first consideration; however, the decision is the Board's to make.
 - a. The Honorary National President Lieutenant-General (Ret) André Deschamps, CMM, CD
 - b. Walter Peckham (413 Wing);
 - c. Guy Vallieres (394 Wing).

LGen (Ret'd) Andre Deschamps has indicated that he would be honoured to accept a (re) nomination to the Hon President position. Regarding the other positions, before the Board decides to whom they may wish to extend invitations to become Appointed Directors, the elected directors may wish to issue a general call for volunteers both inside and outside the RCAF Association, to serve in the capacity as an Appointed Director. As you know, we are attempting to recruit people with specific skill sets to our board.

Finally, the Canada Not-for Profit Corporations Act limits the number of official (remunerated) directors to those specified in the RCAF Association's constitution and by-laws; namely, nine elected and three appointed, but also permits the addition of any number of other non-official, non-remunerated appointees as may be required by the elected board of directors. Thus, we can seek other people for our Board (perhaps members of our Stakeholder's boards?) that can assist us.

A Zoom Meeting Invitation will be sent out for the Swearing-in Ceremony, and first meeting of the newly elected board of directors.

The term of service for this new board will be for two years, wherein a new election will be needed on or about mid-2026, notwithstanding the possibility one or more of the elected directors identified above may have reached their two-year term before that date. IAW our processes, an election will likely be needed for these one or more spots. It will be the Board's decision.

Following the election of a chairperson, and the appointment of appointed directors, the entire board will be required to consider the distribution of offices, duties, responsibilities, and other general assignments necessary for the good order of business of the RCAF Association.

Again, my sincere congrats to our newly elected board; we have a lot of work ahead of us, and some important decisions to make as we are dragged, kicking and screaming into the next 75 years of service to our country's Air Force.

To allow our process to move forward, I ask that those elected above confirm to our ED, at their earliest opportunity, that they are aware of these results. I will be forwarding some literature shortly to our elected members regarding the TOR and duties of RCAFA Board members.


